Tuition Payments

The registration fee will hold your child's placement until **June 1, 2019**, at which time the first of 10 equal payments is due. Beginning in June, an equal payment is due on the first of each month through March 1st, 2020. Payments are past due on the 5th of each month and a \$20.00 late fee will be assessed. No payments will be due in April or May.

• State Tax Scholarships

If you have enrolled your child in the Arizona State Tax Scholarship program and will be expecting scholarship funds, please be aware that you are ultimately responsible for all tuition and fees associated with your child's placement at New Vistas should these funds not be received by NVCE when *monthly* tuition payments are considered due. Parents expecting tax scholarship funds must make a minimum payment in June and July of \$500 per child. When tuition payments are paid in full for the year, this deposit will be refunded. Activity fees cannot be paid with tax scholarship funds; therefore both, semester activity fees must be paid in June for all scholarship students.
